## **News: Devolution gathers pace**



Following the success of devolution of transport powers in London and Scotland, devolution is accelerating elsewhere in the UK. New buses legislation is expected to give transport authorities in England more effective tools to plan and coordinate bus services including the franchising of bus networks. Powers over local rail services are also being devolved, with rail services in the North of England the latest to benefit from devolution through Rail North, the body responsible to local government in the North. Meanwhile new pan-regional bodies for the North ('Transport for the North') and the Midlands have been created to determine strategic infrastructure priorities in their respective regions.

#### **Policy: Horizon Scan**



Our major urban areas are experiencing a period of accelerating technological and social change. Demographics, the capabilities of smart devices, the expectations of citizens, and even the climate itself are all changing. The pace of change can be bewildering, as in a few short years new developments, from social media to Uber, move rapidly from the margins to the mainstream. The challenge for our cities is how they respond. Will they be swamped, constantly playing catch up to successive waves of change? Or will they be forward thinking and respond dynamically, intelligently and adeptly? In our new Horizon Scan report (which can be downloaded

here) we seek to provide a concise summary and horizon scan of likely transformative trends, the implications for urban transport policy, and how forward thinking cities and city regions might respond.

### Policy: Liverpool brings dementiafriendly transport to Brussels



A seminar on 'Getting on Track:
Accessible Transport for Older
People' took place in Brussels in
October. It was organised by
Liverpool City Region in
cooperation with six other EU
regions, as well as EU networks
AGE Platform Europe and Polis.

It attempted to unlock the social and economic potential of smart solutions for accessible transport for older people and allow participants to discover:

- The importance of cycling and walking for physical and mental health;
- How communities gain resilience by providing smart transport solutions for people with dementia;
- The benefits of providing smart bicycles for older people and people with disabilities.

The Liverpool City Region speakers were from Life Story, a local voluntary sector network working specifically on transport and dementia.
